

MERIC Information Brief 2016 Average Annual Wages

Missouri Wage Trends

Missouri ranked 26th in the United States (U.S.) for average annual wages in 2016. The Missouri average annual wage for employees working for private firms was \$46,564, up 1.2 percent from the previous year. The U.S. average annual wage in 2016 was \$53,503.








Missouri's wage growth matched the U.S. in 2016, growing 1.2 percent. The fastest growing wages in the U.S. were found in Washington State (4.5)percent) and Nevada (3.2 percent). States more reliant on energy production showed lowest levels of wage growth, including: North Dakota, Wyoming, Alaska, West Virginia and the southern plains states.

Over a five year period (2011 to 2016), Missouri closely tracked the U.S. average for annual wage growth. Missouri's average annual wage grew at an average 2.2 percent per year, compared to 2.3 percent for the U.S.

Missouri wages were in line with its neighbors to the east (Illinois, Kentucky and Tennessee). It







outpaced wage growth of its western neighbors (Kansas and Oklahoma) and had lower wage growth than its neighbors to the north (Iowa and Nebraska).

Over fifteen years (2001 to 2016), Missouri's average annual wage grew an average 2.4 percent per year compared to 2.6 percent for the U.S. The graphs to the left provide the average annual wages and the growth rates from 2001 to 2016 for Missouri and the U.S. The graphs show Missouri closely follows the U.S. in regards to average annual wage growth, especially since the end of the recession in 2009.

Industry Analysis

Management of Companies had the highest average annual wage in 2016 in Missouri among all industries, with an average annual wage of \$97,070. Utilities (\$90,205) ranked second and Professional, Scientific and Technical Services (\$74,721) ranked third. The full list of Missouri 2016 average annual wages by industry and the U.S. comparison is provided in the table to the right.

Finance and Insurance had the fastest growing wages in Missouri from 2011 to 2016, growing 3.5 percent per year on average. Real Estate was second in wage growth from 2011 to 2016, averaging 3.3 percent growth.



Missouri Regional Wages

In Missouri, wages were highest in large population centers. The St. Louis area had the highest average annual wage for 2016 at \$53,506, and Kansas City was second with an average annual wage of \$50,351. The Northeast Region had the fastest growing wages from 2011 to 2016, increasing an average 2.8 percent per year.



The map of average annual wages by county in Missouri further shows higher wages are often found in large population centers. St. Louis City (\$57,846) had the highest average annual wage in 2016 among all counties, with St. Louis County (\$56,647), Jackson \$53,426), Clay (\$47,020) and Platte (\$44,272) rounding out the top five.

Eight of the top ten counties, in terms of average annual wage, were part of a Metropolitan Statistical Area (MSA). Non-metro counties within the top ten for average annual wages included Ralls County (\$43,828), ranked sixth, and Ste. Genevieve County (\$40,961), ranked tenth.
